- Twenty-five percent (25%) of this option vested and became exercisable on September 1, 2022, with the remainder vesting in thirty-six (36) equal monthly installments thereafter.
- This option shall vest and become exercisable in forty-eight (48) equal monthly installments commencing on January 6, 2022.
